Parish Council & Village News - October & November 2023

Street Lamp 22, adjacent to *The Cottage*, Chelveston and 1 Water Lane, is still waiting for Telent (Openreach's contractor) to sort out a date with National Grid to temporarily make safe and remove the power cable before they can replace the rotting BT pole.

This was originally all supposed to have happened in April, but is now proposed for week 23rd October.

Speed Indicator Devices (SIDs). Originally purchased as battery powered, the effort involved in safely swapping the battery packs has prompted the Council to look at alternative power sources.

The Council are awaiting costs from the supplier to convert two of the SIDs to solar and one to mains transformer, so that they will be active more often.

Community Minibus survey results. From the 2017 Parish Appraisal, we estimated approx. 20% of households in the parish would be eligible (now or soon) for concessionary bus passes, providing free off peak travel.

By the survey closure date, only 5% of households responded, of which 2/3^{rds} of whom had bus passes (or would have in the next 5 years). Rushden and Rushden Lakes were the top destinations for off peak travel, along with Raunds GP surgery for medical visits.

Accordingly, at this time, the Parish Council does not consider there is sufficient demand to part fund a regular off peak service.

Allotment shed replacement: The Parish Council is grateful to the Foulger Trust for a grant to fund the first phase of the allotment shed project. The grant of £2,419 covers not only the purchase of the new sheds, but the labour to erect them and the disposal costs of the old ones. The award of the grant means that there will be no cost to the rest of the parish.

The allotment tenants were surveyed on the specification of the sheds and their preferences have been included. The first four sheds (the ones in worst condition) will be replaced this autumn, by a local handyman, Alistair Mead. Alistair is a semiretired carpenter with 35 years' experience in the construction industry.

External Audit: The Parish Council's external auditor, PKF Littlejohn LLP, has concluded their audit into the finances for the year ending 31st March 2023, with no matters arising.

Whilst the Council's turnover is below the threshold for mandatory audit, the Councillors believe it is important to demonstrate to the residents that the Council's finances are being managed lawfully. School House. You may have noticed that the School House next to the Village Hall is swathed in scaffold and wondered why. Well here's the reason... In 2022, during a storm, a large slab of render fell from one of the chimneys and landed in the front garden, sticking up like a tombstone. We were fortunate that no one was hurt, and that there was no other damage. This repair was covered by insurance, but an aerial survey by Mike Maywood revealed that the other chimney also had serious cracks in the render.

With this knowledge, the Trustees needed to plan a full repair to avoid the risk of injury or property damage. Re-rendering work started in mid-September and was scheduled to last one week. Unfortunately on day one, it was found that the whole chimney was unstable. It had only been held up by the remaining cracked render, which had just been removed! The immediate demolition of the chimney was ordered and the building was made safe before the end of the day.

The next morning Michael Farrow was able to complete a survey. Cement render had apparently been wrongly installed in the mid 1980s, allowing water to penetrate the underlying limestone. This stone had then crumbled in the frost leaving the mass of chimney brickwork perched on wafer thin crumbling stone. Unfortunately, part of the gable wall had also been rendered in cement (instead of lime) and this also needed to be demolished.

Michael Farrow has been engaged to rebuild the chimney and complete the repairs. In the fullness of time (when funds allow), the remaining render on the other chimney will also be examined. The current work may take another month, but it should last another 100 years.
