### Parish Council & Village News - February & March 2024

Wellingborough & Rushden Parliamentary By Election on Thursday 15<sup>th</sup> February. Given the amount of flyers that have arrived through your letterbox, it would be difficult not to be aware of this!

If you are voting in person at the Village Hall Polling Station, please remember that you will need to take photo ID with you in order to vote (e.g. bus pass, passport, driving licence).

**Street lamp 22**, adjacent to *The Cottage*, Chelveston and 1 Water Lane, is heading for its first anniversary (April) of waiting for Telent (Openreach's contractor) to sort out a date with National Grid to make safe and temporarily remove the power cable, before they can replace the rotting BT pole.

The latest instalment of this ongoing saga is that Openreach are now going to re-examine the pole to see if it needs replacing after all.

Allotment shed replacement: In the last newsletter we advised that the Council had submitted a grant application to the NNC Community Support Fund (funded by the Government's Shared Prosperity Fund) for the replacement of the remaining 12 worn out allotment sheds.

Unfortunately, this was unsuccessful as the fund was oversubscribed, but our application was transferred over to the Household Support Fund (also Government funded) and we have just been awarded over £6,000.

**Village Hall closure:** The Village Hall will be closed for maintenance from 2<sup>nd</sup> - 14<sup>th</sup> April 2024. New ceiling access panels are being installed and the ceiling is being redecorated. This work is part of a 10 year programme of maintenance and development agreed by the Trustees at their Annual Meeting in January.

Further work will take place in the paddock during May 2024. New underground rabbit fencing will be installed to persuade our furry friends to stay in the roadside ditch. Currently they are burrowing though the paddock into the Village Hall garden. Rabbitophiles can be assured that none will be hurt during the execution of this operation!

Hillside Illuminated bollard: This has finally been repaired after 15 months by the owner, the Longhurst Group, following the Council's request for intervention by the NNC Health Protection Team and the local division of the Health & Safety Executive.

Water Lane 30 sign: The knocked down sign has been replaced, but the old one is still in the brook! Northants Highways are aware and will collect it in due course.

A 20 mph zone update: At the December meeting, the Council agreed to support a resident request for a 20 mph limit within the centre of Chelveston. The Council has previously asked for a pedestrian crossing point over the B645 at *Cornerhouse Cottages*, but this was rejected due to road safety technical issues. Lowering the speed to 20 mph is another way to facilitate safer crossing.

The Council has asked Northants Highways to confirm what level of public support is required for a 20 mph Order, and agree the limits of the zone for compliance, such that the Council can canvass the electorate for their views (for or against) with accurate information.

**Budget and Precept:** At the January meeting, the Council agreed a balanced budget for 2024-25, with a Precept (local tax) of £12,360. The Councillors were conscious of the rising costs faced by many residents, so limited the Precept increase to just 3%. For a Band D household, this means the parish tax element will be £2.64 (~5p / week) higher.

**Parking on pavements:** The Council has been contacted by a number of residents concerned about vehicles parked partially on the footways or pavements adjacent to the road.

The Highway Code (as at 2023) covers this at -

Rule 145 "You MUST NOT drive on or over a pavement, footpath or bridleway except to gain lawful access to property, or in the case of an emergency." HA 1835 s72 and RTA 1998 s34.

Rule 244 "You MUST NOT park partially or wholly on the pavement in London, and should not do so elsewhere unless signs permit it. Parking on the pavement can obstruct and seriously inconvenience pedestrians, people in wheelchairs or with visual impairments and people with prams or pushchairs." GL(GP)A 1974 s15.

As an offending driver can be prosecuted under the *Highways Act 1835* and the *Road Traffic Act 1988*, this is a police matter. They classify this as Anti-Social Behaviour, therefore residents are directed to report such occurrences online using the link <a href="https://www.northants.police.uk/ro/report/asb/asb-v3/report-antisocial-behaviour/">https://www.northants.police.uk/ro/report/asb/asb-v3/report-antisocial-behaviour/</a>

**Damaged Kimbolton Road gateway:** This was reported to Northants Highways in October 2023, they hope to have it repaired by April.
